The American Herding Breed Association has a progressively structured Test and Trial Program. Below is a guideline from the AHBA site for what is expected for a dog to qualify for each of the two legs in order to earn what is called the HTD or Herding Trial Dog (Levels 1,11,111).

QUALIFICATIONS FOR PASSING HERDING Trial Dog Legs

HERDING TRIAL PROGRAM

The AHBA Herding Trial Program allows herding dogs and their trainers to demonstrate herding skills at graduated levels of herding training. The emphasis is on accomplishment of requirements rather than on competition.

The Herding Trial Program is run on a system utilizing numerical qualifying scores. The "Herding Trial Dog" section, using a standard course, leads to the title "HTD" followed by numerals indicating the dog's level: HTD I (started level), HTD II (intermediate level), and HTD III (advanced level).

ELIGIBILITY

All dogs nine months of age or older are eligible to participate in Herding Trials and JHD. Dogs classified as Herding Dogs in AHBA are eligible for HERDING TEST (HCT). No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test/trial. Bitches in season shall run in drawn running order without adjustment.

IMPORTANT. READ THIS FIRST.

In consideration for participation in an event sanctioned by the American Herding Breed Association (AHBA), I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event. I further agree that I will hold the AHBA, its officers, directors, agents and members harmless and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by me or any dog I have entered in or brought to this event. I agree to indemnify the AHBA, its officers, directors, agents and members for any loss, cost or expense including attorneys fees and costs, to which the AHBA, its officers, directors, agents or members might be subject as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to this event. I acknowledge that while the AHBA may provide sanctioning for this event with regard to the issuing of titles, it does not have and does not exercise control over the conduct of the event or those present. I certify and represent that the dog or dogs I have entered in or brought to this event is/are not a hazard to other dogs, other animals, or to people.

I further agree that I will hold the owners of the facility (Tanya Wheeler of Tucker Creek Farm) and the stock, harmless, and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by or to me or any dog I have entered in or brought to this event.

I also agree to pay the full market value (\$200.00 for sheep and \$20.00 for ducks), of any livestock death resulting from my dog's actions, whether willful or accidental, or in the case of injury to any livestock, resulting from the dog's actions, I agree to pay all veterinary fees up to the market value of the animal.
