## **ABOUT Kent & Lori Herbel**

Kent is well known for his ability to read and understand dogs and handlers as well as livestock, and is a great communicator as well as educator. Kent and Lori have been raising and training dogs together since 1979. The emphasis at their training facility in western Oklahoma is on producing a quality stock dog for ranch or trial work.

Kent began learning the ropes in dog handling at a very young age, as his parents owned German Shepherds well before he was born. Kent spent several of his younger years on the east coast, before moving back to Kansas in the mid 70's. This was his first introduction to using stock dogs on the family-owned cattle ranch. Since that time, he has worked on ranches in Kansas, Texas and Oklahoma, and he and Lori now own the XP Ranch. Lori grew up on a farm in north central Kansas with, interestingly, a German Shepherd as the family pet.

The Herbels began training dogs together in 1979, originally specializing in training Labrador Retrievers as gundogs. Their first stock dog was purchased in the mid-80's, and gradually the switch was made to training herding dogs. Kent has trained and handled national winners at the Australian Cattle Dog Nationals, Border Collie Nationals, German Shepherd Nationals, and the Briard Nationals. He has trained and trialed multiple dogs successfully to the Herding Championship level as well as having trained successful Open level dogs in the USBCHA. He has qualified for and placed at the Finals at the USBCHA National Cattle Finals.

Lori has trained and trialed to the Herding Championship level as well and was the trainer/handler of High in Trial at the 2001 BCSCA National Specialty. You can read more about Kent and Lori on their web-site <http://xpranch.tripod.com/index.html> .
